The RECIPIENT and RECIPIENT Scientist agree that they shall not further distribute or transfer the DATA to others without the PROVIDER's written consent. To the extent possible, the RECIPIENT or the RECIPIENT SCIENTIST agree to make the DATA available, under a separate Simple Letter Agreement to other scientists for teaching or not-for-profit research purposes only. The RECIPIENT agrees to acknowledge the source of the DATA in any publications reporting use of it.

Unless prohibited by law, Recipient assumes all liability for claims for damages against it by third parties which may arise from the use, storage or disposal of the DATA except that, to the extent permitted by law, the Provider and Transferor shall each be liable to the Recipient when the damage is caused by gross negligence or willful misconduct. 7.
